## 3 charged in fatal shooting

Last week three men were charged in a fatal 2017 shooting that took place in the North Broadway neighborhood of Cleveland.

Daniel White, 39; Danzel Washington, 27; and Norman Ross, 23, were charged with murder in a shooting near Mead Avenue that happened on September 4, 2017, according to court records.

A preliminary hearing is scheduled for White on April 8. Washington and Ross have warrants issued but are not in custody.

## I-77 south exit ramp to Rt. 21 to be closed April 15 for 100 days

On Monday, April 15, the I-77 southbound exit ramp to Rt. 21 (Brecksville Rd.) in Cuyahoga Heights will close for 100 days in order to replace the exit ramp bridge. Motorists will be detoured via I-77 south to 1-480 eastbound to Rt. 17 (Granger Rd.) to Rt. 21 (Brecksville Rd.)

Temporary complete closures of I-77 north and south may take place to accommodate bridge demolition and construction operations. Detours will be posted.

The project was awarded to J.D. Williamson Construction Company, Inc. for \$7,848,580 and is expected to be completed in June 2019.

## New felony sex charges for ex-Cleveland officer

A former Cleveland police officer who was charged with two felony sex offenses in February stemming from an incident in Garfield Heights is now facing a 21-count indictment with new charges.

On March 8, 2019, Mario Lozada, 55, now retired from the force, was indicted on sex offense charges for paying a 15-year-old girl to engage in sexual activity, according to Ryan Miday in the Cuyahoga County prosecutor's office.

The indictment also charged Lozada with underage alcohol use for purchasing alcohol for the girl. The twelve charges in the indictment include four counts of unlawful sexual conduct with a minor, two counts of pandering sexually-oriented matter involving a minor, four counts of compelling prostitution, one count of improperly handling firearms in a motor vehicle and one count of underage alcohol use.

Since the indictment, CPD Internal Affairs' continuing investigation revealed that Lozada unlawfully accessed the law enforcement automated database system (LEADS), Miday said.

The investigation also identified a 17-year-old girl from whom Lozada solicited nude photos, according to Miday. Lozado was reindicted by a grand jury on additional charges including eight counts of illegal use of minor in nudity-oriented material or performance and one count of unauthorized use of property.

Lozada is scheduled to appear at an April 9 arraignment hearing, according to court records.

His previous charges include pandering sexually oriented material involving a minor and unlawful sexual conduct with a minor. They stem from a July 13th incident near Jack C. Donovan Park in Garfield Heights in which police discovered Lozada in an SUV with a then 14-year-old girl.

When she's not skating Azlan can be found volunteering at Momentum Church, playing with her big dog, Sully, studying for tests or hanging out with her family and friends.


