## Garfield Hts. closes civic center, cancels Ice Show

Due to the health crisis caused by the novel coronavirus, the city of Garfield Heights has closed the civic center and sent all employees home, except for police, fire and some service department personnel, according to Mayor Vic Collova. The closure begins today, March 18.

He said the city has also canceled/postponed its 52nd Annual Ice Skating Show – “Magical Moments on Ice,” scheduled for Saturday, March 28. Collova has also approved modifications to various city programs and services.

The Senior Center will be closed until further notice. There will be no interruption in home-bound meal delivery and transportation services provided by the Senior Center will be for medical appointments only. Food bank will be open Wednesdays, 1-2 p.m., and Thursdays, 6-7, for those already signed up.

The recreation center will be closed for all events.

### New protocol for GHPD, GHFD

The Garfield Heights Police & Fire departments have enacted some new protocols based on recommendations from health care professionals in light of the current COVID-19 outbreak. These protocols are temporary and are for the protection of first responders and the public.

“After the fact” police reports will be taken over the phone. Contact police dispatch at 216-475-1234 and advise dispatcher of your complaint. The dispatcher will assign an officer to contact you via phone.

The public is encouraged to avoid coming to the station. The same procedure as above will be followed for non-emergency situations. And all jail visitation has been suspended during this time. The fire department will be closed to the public until further notice, including tours and meetings held downstairs.

If you have an emergency, call 911, and do not hesitate to call if you need emergency responders. Some additional information for a proper response may be required.

## Our opinion ‘DeWine Intervention’

The new coronavirus outbreak continues to wreak havoc on the ordinary lives of people in our local communities and around the world. The polls were closed yesterday, St. Patrick’s Day parades and festivities canceled, restaurants closed for anything but takeout, meetings canceled, government buildings, movie theaters, bowling alleys and gyms among the hundreds of places shut down until further notice.

His daily news conferences from the front lines, along with the input from Ohio Department of Health Director Dr. Amy Acton and Lt. Gov. John Husted, tell us frankly and without sugarcoating what is happening as this pandemic continues to escalate and the directives the state is taking to be proactive against this new and deadly virus.

Gov. DeWine stands before us behind his podium at the statehouse in Columbus each day and calmly reassures Ohioans that we are all in this together and, although the time frame is uncertain, this, too, shall pass.

Our local officials have also stepped forward to guide their communities through the uncharted waters of this viral outbreak. This week most of The Neighborhood News articles are devoted to the response of local leadership to the COVID-19 pandemic.

So it is incumbent upon all of us to abide by our leadership’s precautionary directives and stay safe, stay optimistic, and, if possible, stay home.

## COVID-19 makes changes in Cuyahoga Heights

Effective March 17, 2020, the following changes will be implemented for the Village of Cuyahoga Heights. All village activities will be suspended until further notice.

All nonessential meetings have been canceled. All public access to the Village Hall is currently suspended. A box at the back entranceway of the Village Hall will be established for drop off and pick up of any necessary paperwork during normal business hours, Monday through Friday.

Meetings of council and boards will be updated as dates near. For additional information, contact the Village Hall staff at 216-641-7020, or email to [chv@cuyahogaheights.com](mailto:chv@cuyahogaheights.com) for any questions and assistance.

All nonessential meetings have been canceled, as well as public activities within the police and fire department’s facilities.

All nonessential meetings have been canceled in the service department building which is closed to the public. Trash pick up and special pick up will proceed as scheduled.

Meals on Wheels, transportation to essential doctors’ appointments and grocery shopping will continue at this time. All recreation sports and classes will be suspended until further notice.

## Newburgh Heights reacts to coronavirus pandemic

After meeting with senior staff, Mayor Trevor Elkins has taken the following actions to assist with limiting the spread of the Coronavirus.

All public meetings, with the exception of regularly scheduled council, planning commission and board of zoning appeals meetings, are canceled until at least April 15, 2020. Council meetings will be held under an abbreviated agenda.

All Traffic Court and Photo Enforcement Hearings are being postponed and rescheduled until at least after April 15, 2020.

All use of the community room/senior center will be canceled until at least April 15, 2020.

Village buildings will be sanitized and extended efforts to sanitize the premises will occur on an ongoing basis.

All in-person youth athletic sign-up events will be canceled. Sign-ups will occur via email and telephone.

All employees are prohibited from traveling outside of

the United States. Any employee that does travel abroad will be required to quarantine for 14 days before returning to duty.

All personnel exposed to an infected individual, or experiencing symptoms themselves, are required to report these to their department head immediately so the Cuyahoga County Board of Health can be properly notified.

The public will be screened before entering the premises.

Paid leave will be granted to individuals with families affected by Coronavirus as the result of school closures, illness or exposure to COVID-19.

“We view this as a serious issue,” said Elkins. “The safety of our employees, our residents and the general public is of the utmost importance to us. It is the opinion of our professional staff that these steps are necessary to protect the residents of Newburgh Heights, and the public at large, by slowing the spread of the virus.”



# City of Cleveland buildings closed to public; will offer limited services

In accordance with Cleveland Mayor Frank G. Jackson's recent Proclamation of Civil Emergency, the city of Cleveland continues to take numerous precautions across multiple departments and divisions amid increasing cases of coronavirus (COVID-19).

The Cleveland Department of Public Health Monday was notified of one more confirmed test result for coronavirus in a resident of the city. This brings the total to three confirmed cases. The confirmed individual is a male, between ages 30-40.

CDPH is working to identify any close contacts of this

resident who would require testing or monitoring for symptoms of COVID-19.

In order to protect the individual's privacy, the Cleveland Department of Public Health will not be releasing any additional demographic information related to these new cases.

## Continuity of operations

To help ensure the safety of employees during COVID-19, the city of Cleveland is moving to an essential workforce and will not allow public access to certain city buildings. All employees will be paid as normal.

City Hall will be open Tuesdays and Wednesdays from 9 a.m. to 2 p.m. for limited public services. On Mondays, Thursdays and Fridays, City Hall will be closed.

Areas closed to the public, with limited public services include:

- Department of Aging (some daily senior services will be accessible via phone);

- Department of Public Health, Office of Vital Statistics - Drop-boxes are available. Birth and death certificates will also be available by mail, via phone through VitalChek or online at [www.clevelandhealth.org](http://www.clevelandhealth.org);

- Department of Public Utilities - Customers are still able to call in for account services;

- Department of Economic Development - Limited services are available by appointment only;

- Division of Taxation - Services available via dropbox;

- City Prosecutor's Office - Due to the COVID-19 restrictions, the City Prosecutor's office will take citizen complaints involving fresh arrests only.

All public meetings, including boards and commissions will be canceled.

Cleveland City Council will meet on Monday, March 23, for the 7 p.m. council meeting.

Further information will be provided by Cleveland City Council's Office of Communications.

Essential members of the Department of Public Safety will continue to operate at full capacity amid coronavirus concerns.

Citizens should call 9-1-1 if they experience life-threatening symptoms like chest pains or shortness of breath.

## Notice of closing Maple Heights City Hall, Senior Center to public; some services continue

Maple Heights Mayor Annette Blackwell this week convened city leaders to discuss an immediate response to the COVID-19 pandemic and the best ways to keep city employees, residents, especially seniors and those most vulnerable to the virus safe from infection and illness while insuring city services continue without interruption.

The decision was made to close City Hall and the Senior Center to the public, beginning March 17, until further notice.

A notice of closure is on the main entrance door advising of the closing and listing the phone numbers for each department so that individuals that have an authorized appointment with a particular department can call to be let into the building.

The Building Department, Mayor's Court and Senior Center will continue to provide services to residents and other members of the public as follows:

- The Building Department staff will still be required to report to work. Plans are in the works to handle permits and registrations via regular mail. In addition, Economic Development Director Grogan-Myers and staff will be working on updating Building Department forms to make them fillable PDFs and exploring the possibility of online payments.

Last Thursday, March 12, the law director ordered the Mayor's Court hearings for March 17 and March 31 to be continued to April 14 and April 28, respectively. With the closing of City Hall, access to the Mayor's Court window will not be possible. A notice is posted on the City Hall entrance door advising individuals to drop cash or check payments into the lock box outside the door. The Senior Center is closed to the public as of March 17. Seniors, however, will still be provided meals. Staff will deliver their meals to their homes and hang on their door knobs. Meals for the home-bound seniors regularly serviced will continue as usual. All transportation has been halted except for dialysis patients. The Mobile Farmer's Market will be open on Thursday, March 19, from 9:30-11:30 a.m.

## Boys & Girls Clubs in region to close for next three weeks; non-school club sites in Cleveland to offer pickup meals

Boys & Girls Clubs of Northeast Ohio has made what its interim president described as "an extremely difficult but necessary decision" to close all of its 39 locations for three weeks, starting last Friday.

Ron Soeder, interim president and CEO of the organization, said BGCNEO will reevaluate conditions at the end of the shutdown period and determine whether or not to reopen clubs on April 6.

In Cleveland, BGCNEO will offer free meals for pickup

by members and their families between noon and 1 p.m., Monday through Friday, at the following club locations: Broadway, 6114 Broadway Ave., Cleveland 44127; King Kennedy, 2561 E. 59 St., Cleveland 44104; and Saint Luke's, 2705 Martin Luther King Jr., Cleveland 44104. Pickups will continue at least through March 31.

"We know many of the kids who come to our clubs depend on us for a hot meal, and we are doing everything we can to ensure that is not taken away from them, even temporarily," Soeder said.

## Laws of the Land in G.H.

Do you live in Garfield Heights and have a question about its ordinances - what may or may not be legal in any given circumstance? This column will help get answers.

It is also against the law to operate toy vehicles such as electric razor scooters, mopeds, etc.

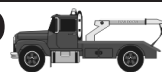

# Bedford canceling, postponing events due to coronavirus concerns

Due to ongoing concerns about COVID-19, the novel coronavirus, and acknowledging the preventive measures announced by the State of Ohio and Governor Mike DeWine, Bedford City Manager Mike Mallis has announced that a number of events have either been canceled or postponed in the city of Bedford in the coming weeks.

"While there is no reason to panic, the city is following direction from the Cuyahoga County Board of Health, the Ohio Department of Health, and the Center for Disease Control and Prevention," Mallis said. "I would like to reassure residents that although these preventive measures are intensifying and you may encounter increased disruption in ordinary life, these decisions are made out of an abundance of caution, and our strategy now is to mitigate the community spread."

Bedford City Hall, 165 Center Rd., will continue to remain open for business. "It is scheduled to be cleaned every morning starting at 5:30 a.m., prior to the start of business. We are also taking steps to further sanitize the public buildings on a regular schedule," Mallis said.

Residents are encouraged to avoid in-person visits to City Hall and instead use the city's online services where possible, e-mail, or call respective departments for needs or questions, Mallis said. Residents can call 440-232-1600.

The city of Bedford has made the following decisions pertaining to programming, meetings and services in the city:

All Senior Club activities and luncheons have been postponed until Monday, April 6.

The Senior Health Fair, scheduled for Wednesday, March 18, has been postponed.

Parks and Recreation Department programs and Ellenwood Center rentals from now through April 6, including the Parks and Recreation Center Town Hall Meeting on Saturday, March 21, and the Easter Egg Hunt on Saturday, April 4, have been suspended. "Participants registered for programs scheduled to take place during this time are eligible for a full credit or refund," Mallis stated.

The Senior Transportation Connection will continue to provide transportation services to Bedford's senior citizens. STC buses are cleaned and sanitized daily, and

drivers are equipped with hand sanitizer.

The Ward meetings that were scheduled for the following Mondays, March 23, March 30 and April 27, have been postponed.

"The Service Department will continue to respond to sewer calls. However, staff members will not be permitted to enter residents' homes," Mallis stated.
