SVD mask distribution

Slavic Village Development will hold a mask distribution in the rear parking lot of their offices at 5620 Broadway Ave., Slavic Village, on Wednesday, July 22, from 6 to 8 p.m. The masks are intended for Cleveland residents and will be first come, first served, while supplies last.

Families will receive 20 disposable masks and 3 cloth masks for each family member. You are allowed to pick up for a neighbor as well. Masks must be worn when arriving at the parking lot.

SVD will also be distributing other COVID-19 supplies such as sanitizer, thermometers, alcohol wipes and more.

Ohio Gov. Mike DeWine recently mandated that face masks must be worn in public throughout Cuyahoga and 11 other Ohio counties in an attempt to slow the spread of the coronavirus.

Charter Steel gets Council OK to construct new electrical power plant in Cuyahoga Heights

The Village of Cuyahoga Heights Council met last Wednesday, July 8, and approved a nonresidential permit to construct a new electrical power plant south of the existing guard station. The new plant will interface with Charter's existing electrical power plant located north of the guard station.

Village Building Commissioner Norm Casini recommended council approval of the permit since the new plant is essential to Charter Steel.

A memorial resolution was passed for lifelong village resident Donald Boing, who passed away June 20, at the age of 90. Mr. Boing was appointed as a police officer in Cuyahoga Heights in 1954 by Mayor William Gerdon. He retired as a lieutenant from the department in 1981.

Other legislation approved last week by council included:

- Authorizing the purchase of general liability and other forms of insurance coverage from Love Insurance Agency;
- Affirming that all funds received from the County Coronavirus Relief Distribution Fund (\$15,273.89) be expended only to cover costs consistent with the requirements of Coronavirus Aid, Relief and Economic Security Act and establishing a local Coronavirus Relief Fund;
- Executing an agreement with Cuyahoga County for the resurfacing of Grant Ave. from E. 49 St. to E. 71 St.;
- Purchasing a new fuel system and all hardware and software needed not to exceed \$28,000. The fuel management system is an automated fuel control system used to run the existing gas pumps for fueling village vehicles;
- Regulating the operation of certain motorized vehicles in the village.

Racial unrest in Garfield fueled by councilman's Facebook postings

Garfield Heights Council met in regular session by telephone conference call Monday night, but the 4th of July fireworks the mayor told residents to put away for the season erupted verbally at the meeting with calls for the censoring, firing or recall of Ward 2 Councilman Charles Donahue.

The discussion, which was kept civil and professional by all those with input, centered on a Facebook posting by Donahue some weeks ago that showed a sailor standing at attention in a sports stadium presumably while the National Anthem was being played. Underneath the picture are the words, "Men Stand, Bitches Kneel."

After passing all the legislation on the night's agenda, Council President Matt Burke instructed Council Clerk Barbara Molin to read the Written Communications to Council.

Molin proceeded to read three letters, the first containing 130 signatures, resident James Fruits later pointed out, which said in part that the undersigned did not feel safe having Donahue represent them and would move forward with a recall initiative.

Another letter from an Eastwood Ave. resident pointed out the growing racial tension in the Garfield Heights community and the need for police reform. She said she was present at the policing meeting last month at The Rock Church and felt defeated by comments by Mayor Vic Collova and Ward 3 Councilman Mike Nenadovich that they were "100% behind the Garfield Heights police." She questioned what percentage was then left for residents.

A call-in resident said she didn't feel safe with GHPD Officer Michael Malak on the streets after the incident shot on video of his forceful interaction with Kenta Settles on Turney Rd. last January, and called for his removal from the force. A police brutality lawsuit against five officers of the GHPD, including Malak, has been filed on behalf of Settles claiming excessive force and violation of the plaintiff's civil rights.

Also called into question in a letter from resident Lanene Jones was what she termed a "road rage" incident a few weeks ago in the Giant Eagle parking lot between Donahue and a black man who had earlier "cut him off" while driving.

"As an elected official, you could've taken the high road and still introduced yourself and asked him to be careful when driving around there," her letter stated.

An earlier letter to Donahue from Ward 4 Councilwoman Shayla Davis and Ward 5 Councilman Jason Blake, in referring to the incident, said, "Although no arrests were made by the police department, we believe the conduct is unacceptable.... We are not asking for your dismissal from Council. However, we are asking for more prudent actions when dealing with the public."

Fruits, who with Rock Church Deacon Michael Peters organized the June 25th policing meeting, said Donahue should apologize for his actions and step down from council and asked Mayor Vic Collova on his take of the situation.

"I totally disagree with kneeling at the flag," he said. "But the residents vote us in and they can vote us out. The people put him (Donahue) in, let them take him out by a vote of the people."

He said he was in total agreement with the Black Lives Matter movement but think they have gone too far.

Fruits said Officer Malak should be put on administrative leave.

PAUL WILLIAM LIPTAK died Monday, June 29, 2020, at Holy Family Hospice following an eight-month battle with kidney cancer at the age of 80 years old. Born May 28, 1940, he was the second oldest of Andrew and Mary (nee Uhrin) Liptak's 11 children. He was baptized and confirmed at Holy Trinity Lutheran Church. Paul was a 1959 graduate of South High School where he participated in decathlon and baseball. For a short time he was a cab driver, and knew a dozen different routes to any destination in Northeast Ohio. He was employed as a Sr. Test Engineer at Republic Steel/LTV Steel/ISG Steel for more than 42 years. He was a member of the Ohio Army National Guard in the 1960's.



On May 22, 1965, he married Elfriede Samulkewitsch at St. John's United Church of Christ on East 55th in Cleveland. Paul and Elfriede purchased a home in Garfield Heights in 1966, where he lived for 54 years. They raised six children, two of whom were foster children which the family later adopted. All six children attended St. John Lutheran Elementary School in Garfield Heights and Lutheran East High School in Cleveland Heights. He spent a great deal of his time happily chauffeuring children to and from school, sporting events, Singing Angels rehearsals and concerts, and after his retirement drove Elfriede to and from work downtown every day, often stopping at The Red Chimney for breakfast.

Paul was a big Cleveland Indians fan and if he wasn't at Progressive Field with one of his kids watching the Tribe in person or watching them on TV, he was listening to the games on the radio (even if he was taking a walk on the Towpath with Elfriede, their kids or grandkids). He absolutely loved bowling and up until fall 2019 he was on three separate bowling leagues a week. Paul was a member of Immanuel Ev. Lutheran Church in Tremont for 52 years, most of those as a council member and trustee. He assisted with teaching Vacation Bible School, delivering his homemade sloppy Joes to hungry VBS students and sang in the adult choir at Immanuel. He loved photography and traveling. Over the years, Paul traveled to Hungary, Czechoslovakia, Japan, China, Puerto Rico, Germany, Austria, England, Ireland, a cruise to Cancun, Caymen Islands and New Orleans, an Eastern Caribbean cruise, Oberammergau, Germany to see the Passion Play, Canada, many destinations throughout the United States, and multiple times to Washington, D.C. (several times by train) to see the cherry blossoms bloom and attend Easter sunrise services at Arlington National Cemetery.

Paul W. Liptak was the beloved husband of the late Elfriede (nee Samulkewitsch) for 48 years; loving father of Ruthanne Chambers (Thomas), Roseanne Scott, Timothy, Richard (Jodie), Marianne Brady (Robert) and Michael (Julie); cherished grandfather of Michael and Breanne Chambers, Megan and Matthew Scott, Corey, Connor, and Tyler Liptak, Josephine Brady, and Michael Liptak, Jr.; adored son of the late Andrew and Mary; caring brother of Andrew (Kathleen) Helen Suckow (Charles, deceased), Thomas (Jacqueline), Michael (deceased) (Susan), Judith Sledz (James, deceased), Martin, George (Michelle), Mildred Delphia (Albert), Margaret Quella (Stephen), and Stephen (Charlotte); dear brother-in-law, cousin, uncle, great-uncle, and great-great-uncle to many. V.V. Council votes to bring back recycling

At last week's regular monthly council meeting in Valley View on July 7, council members authorized the village to bring back the recycling program.

Councilman David Wingenfeld said he had spoken with Cuyahoga County Solid Waste Management regarding the recycling program. He said that Kimble would charge \$30 less per ton to recycle. Wingenfeld added that he would like to place bins in a central location, possibly behind the old service garage.

Mayor Jerry Piasecki asked Wingenfeld to provide a procedure of how the program will work.

The following ordinances and resolutions were among those passed last week by council:

- Creating a new fund called "The Local Coronavirus Relief Fund in the Village of Valley View;
- Transferring funds from the General Fund to the Police Pension Fund;
- Transferring funds from the General Fund to the Fire Pension Fund;
- Accepting a Storm Water Management and Access

Easement for 9755 Corporate Circle. Piasecki said this was needed for a new building going up on Corporate Circle;

- Executing three State-Local Grant Agreement Amendments between the Ohio Emergency Management Agency and the village as part of the Hazard Mitigation Grant Program. Piasecki said for each of the ordinances, FEMA is allowing the village to charge 5% administration fees;

- Providing additional appropriations for the fiscal year ending Dec. 31, 2020.

Council also approved several purchases at the meeting, including replacing the existing trane air handler at the fire station from the Geopfert Co. at a cost of \$35,330; a new motor for the Strathmore Pump Station at a cost of \$3,500 to replace the existing 10 horsepower motor; hiring Specialized Construction for full depth flexible pavement repairs on Fosdick Rd. at a cost of \$6,160; and repairs to Engine 35 in the fire department at a cost not to exceed \$7,000.

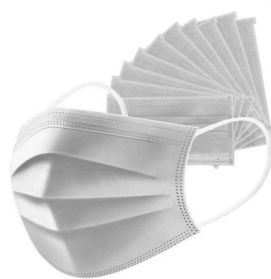

Racial unrest in Garfield

“Our city needs to hear a lot more from city leadership – all I hear is defensiveness,” Fruits said. He questioned the kind of training council members receive when elected and would like transparency on the search for a new police chief in the city.

Donahue defended himself at Monday’s meeting, which approached three hours in length, by saying the sailor photo wasn’t racial. “It was about football players kneeling during the National Anthem. They took a post I shared and blew it out of proportion.”

“I’m not a racist,” he said, “and I’m not stepping down. I’ve done nothing wrong.”

On Donahue’s most recent Facebook posting, he said: “It has been brought to my attention that because of my being on Garfield Heights City Council, that I don’t have freedom of speech. Some have even brought up my possible removal from Council.

“Because of this, this will be my last post for while. I am committed to helping the residents of my Ward and do not want to jeopardize my being removed from Council and being replaced by someone that doesn’t care about the people and only wants to further his or her career.”

Farmer Jones Market in Maple Hts. plans reopening with new owner, operator

For more than 60 years Farmer Jones Indoor Market, 16701 Broadway Ave., Maple Heights, provided a wide selection of fresh fruits and vegetables to the community all year long, as well as specialty items including honey, fresh chestnuts, hazelnuts, almonds, brazil nuts and walnuts.

Soon after the former owner made the difficult decision to close the market's doors in May 2020, George T. Simon, a local attorney and entrepreneur, purchased the market and has recently identified an operator for the market, the Rid-All Green Partnership.

The members of this partnership are three childhood friends, G. Keymah Durden, Randy McShepard and Damien Forshe (deceased), who grew up together in Cleveland's Lee-Miles neighborhood.

Rid-All Green Partnership is most known for its work in Cleveland's Lower Kinsman neighborhood where it turned

an empty and forgotten section of land known as an illegal dumping site into a thriving urban farm where various types of produce are grown to bring healthy, local food to area institutions and citizens.

The Rid-All organization also trains youth and adults as part of its life-changing work. These urban farmers have also built two green houses, six hoop houses, a 7,200-square-foot aquaponics fishery and a Class II composting facility on a 15-acre urban agriculture campus.

Maple Heights Mayor Annette M. Blackwell said, "The city is overjoyed that George Simon and Rid-All Green Partnership are partnering to keep the market operating and offering our residents fresh produce throughout the year."

Farmer Jones Indoor Market is planning to reopen under Rid-All's management in late July or early August.

~ Laws of the Land ~ in Garfield Heights

Do you live in Garfield Heights and have a question about its ordinances - what may or may not be legal in any given circumstance? This column will answer your questions with the help of members of Garfield Heights City Council.

Question – What is the law regarding public intoxication?

Answer – The codified ordinances state the following:

509.03 DISORDERLY

CONDUCT; INTOXICATION

(A) No person shall recklessly cause inconvenience, annoyance or alarm to another by doing any of the following:

(1) Engaging in fighting, in threatening harm to persons or property, or in violent or turbulent behavior;

(2) Making unreasonable noise or offensively coarse utterance, gesture or display, or communicating unwar-

ranted and grossly abusive language to any person, which by its very utterance or usage inflicts injury or tends to incite an immediate breach of the peace;

(3) Insulting, taunting or challenging another, under circumstances in which such conduct is likely to provoke a violent response;

(4) Hindering or preventing the movement of persons on a public street, road, highway or right of way, or to, from, within or upon public or private property, so as to interfere with the rights of others, and by any act that serves no lawful and reasonable purpose of the offender;

(5) Creating a condition that is physically offensive to persons or that presents a risk of physical harm to persons or property, by any act that serves no lawful and reasonable purpose of the offender.

(B) No person, while voluntarily intoxicated, shall do either of the following:

(1) In a public place or in the presence of two or more persons, engage in conduct likely to be offensive or to cause inconvenience, annoyance or alarm to persons of ordinary sensibilities, which conduct the offender, if the offender were not intoxicated, should know is likely to have that effect on others;

(2) Engage in conduct or create a condition that presents a risk of physical harm to the offender or another, or to

the property of another.

(C) Violation of any statute or ordinance of which an element is operating a motor vehicle, locomotive, watercraft, aircraft or other vehicle while under the influence of alcohol or any drug of abuse, is not a violation of subsection (b) hereof.

(D) When to an ordinary observer a person appears to be intoxicated, it is probable cause to believe that person is voluntarily intoxicated for purposes of subsection (b) hereof.

(E) (1) Whoever violates this section is guilty of disorderly conduct.

(2) Except as otherwise provided in this subsection, disorderly conduct is a minor misdemeanor.

(3) Disorderly conduct is a misdemeanor of the fourth degree if any of the following applies:

(a) If the offender persists in disorderly conduct after reasonable warning or request to desist.

(b) The offense is committed in the vicinity of a school or in a school safety zone.

(c) The offense is committed in the presence of any law enforcement officer, firefighter, rescuer, medical person, emergency medical services person, or other authorized person who is engaged in the person's duties at the scene of a fire, accident, disaster, riot or emergency of any kind.

(d) The offense is committed in the presence of any emergency facility person who is engaged in the person's duties in an emergency facility.

(4) If an offender previously has been convicted of or pleaded guilty to three or more violations of subsection (b) of this section, a violation of subsection (b) of this section is a misdemeanor of the fourth degree.
