More potential victims sought of alleged **Bedford child molester**

Bedford Deputy Police Chief Rick Suts said last week that David Marek, age 38, of Bedford, has been arrested and charged by Bedford PD for sex crimes involving an 11-year-old female. He said police are trying to determine if there are any more possible victims. Anyone with information is asked to call Bedford PD at 440-232-1234.



David Marek Bedford officers responded to a Regina Dr. home in the early morning hours of Monday, Aug. 24, for a welfare check called in by Niagara Regional PD in Canada. Officers spoke to an 11year-old girl who said that day she had sent a message to her friend in Canada saying she needed police regarding abuse going on in the household. The girl said the abuse had been ongoing since 2018.

The Bedford Detective Bureau learned that from Aug. 25, 2019, to Feb. 29, 2020, Marek had been allegedly molesting the girl and secretly video taping her with a covert camera he had placed in the bathroom and taking lewd pictures of her.

On Aug. 31, after obtaining a search warrant, police searched the Regina Dr. home and arrested Marek at his workplace on charges of gross sexual imposition and took him to the Bedford jail. Additional charges may be filed.

According to the police report, Marek was interviewed by police and admitted to molesting the girl, filming her fatal shooting in the bathroom and taking the lewd photos.

On Sept. 2, Marek appeared in court with counsel and his bond was set at \$1 million. A preliminary hearing was waived and Marek was bound over to the Cuyahoga County Common Pleas Court.

Chief Murphy passes away

Retired Garfield Heights Police Chief Thomas Murphy, 74, passed away over the weekend. Chief Murphy was appointed with the GHPD on Dec. 1, 1966, where earned the ranks of sergeant, lieutenant, captain and eventually chief from Jan. 1, 1990, to his retirement on Jan. 18, 2011. Funeral services will be private with no calling hours.

I-480 east traffic will travel on new Valley View bridge starting Sunday

The Ohio Department of Transportation has announced upcoming ramp and lane closures due to the I-480 Valley View Bridge Deck Interstate 480 Valley View Bridge Deck Replacement Project that is constructing a new bridge between the two existing Valley View bridges and replaces the decks of the I-480 east and westbound Valley View bridges in Garfield Heights and Independence.

- I-480 eastbound between I-77 and Transportation Blvd. will have double lane closures beginning Friday, Sept. 11, at 8 p.m. through Saturday, Sept. 12, at 6 a.m. in order to shift eastbound traffic onto the new I-480 Valley View Bridge. Single lane closures will be implemented on Saturday from 6 a.m. to 6 p.m.
- •The I-77 north and southbound exit ramps to I-480 eastbound will be closed beginning Saturday, Sept. 12, from 6 a.m. to 1 p.m. in order to shift eastbound traffic onto the new I-480 Valley View Bridge. Detour will be I-480 westbound to SR 17 westbound to I-480 eastbound.
- I-480 eastbound entrance and exit ramps at Transportation Blvd. will be closed beginning Saturday, Sept. 12, from 6 a.m. to 6 p.m. in order to shift eastbound traffic onto the new I-480 Valley View Bridge. Detour for I-480 eastbound exit to Transportation Blvd.: Granger Rd. to I-480 west to Transportation Blvd. Detour for Transportation Blvd. entrance to I-480 east: Granger Rd. to Broadway Ave. to I-480 eastbound.

All I-480 eastbound traffic will officially be traveling on the new I-480 Valley View Bridge beginning Sunday, Sept. 13, through Fall 2021 as crews work on the existing I-480 eastbound bridge. Eastbound traffic will still have access to the I-77 interchange and exit to Transportation Blvd. Estimated completion: June 2024.

Maple Hts. Council fails to get votes to declare racism public health crisis

Mayor Annette Blackwell and other officials in Maple Heights have expressed their disappointment at failure of legislation at last week's council meeting that would have declared racism a public health crisis in the city but hope to address the issue in some

The resolution, sponsored by Council members Dana Anderson and Richard Trojanski, stated in part: "Maple Heights City Council wishes to declare racism a public health crisis, and would like to commit to improving the overall quality of life of our minority residents, business owners and visitors.

At the meeting, held via teleconference, Council President Ron Jackson stated that at a Committee of the Whole meeting held earlier last week it had been recommended that the legislation be put forth for a vote at the Wednesday, Sept. 2 council meeting.

Before council's vote to suspend the rules and pass it on emergency, Councilwoman Toni Jones stated, "I am not sure everything is resolved on this piece of legislation, and I am asking the body if we want to put it on first reading right now.

Council voted to suspend the rules requiring first, second and third readings. However, when it came to passing it on emergency, Council's vote was 4-yes, 3-no, with Council members Christian Ostenson, Jones, Anderson and Trojanski voting for it. Council members Stafford Shenett, Tanglyn Madden and Edwina Agee voted against

Law Director Frank Consolo clarified that the legislation failed to pass because there were not five out of seven members, or two-thirds majority, voting yes on passing it on emergency. "It fails and does not go to first reading," Consolo said.

In a statement released after last week's meeting, Blackwell stated, "I am deeply disappointed that this very important legislation did not pass, and that the effort of two city council members (Anderson and Trojanski) to prepare and introduce it was not Detective Bureau at 216-475- supported or respected by the majority of council members.'

COVID-19 evictions could leave more women without a vote: Part I of II

Lynn Rodemann walked up the driveway, a mask fixed tightly to her face.

Amother of five welcomed her into the backyard, where a child's birthday party the evening before.

Rodemann, a community outreach specialist, is part of a pandemic response team traversing Slavic Village to check on residents and offers information on a rent assistance program - and an application to vote by mail in the upcoming November presidential election.

Working the overnight shift as a corrections officer at a women's prison during a pandemic, coupled with limited

"You could see how tired she was," says Rodemann, who broke social distancing protocol to give the woman, who started to cry, a hug. "I was so devastated for her.'

After that encounter, she wondered how a mom like the one she had met could have any energy left to worry about voting. A few days later, Rodemann returned to the home she was cleaning up the colorful, damp decorations from with a care package: masks, alcohol wipes and a thermom-

> "If there's a possibility that they're losing their house, they don't give a s___ about voting," says 39-year-old Rodemann, who has worked for Slavic Village Development in the historic but under-resourced neighborhood for six years.

> "They're worried about keeping a roof over their head and still eating.'

> And just as fears of evictions remain in this community 10 minutes south of downtown Cleveland, it's a concern facing thousands of Americans nationwide.

> Policy experts predict an "avalanche" of evictions to hit low-income renters across the country this fall. Women are expected to be the majority of the 30 to 40 million Americans at risk of eviction by year's end, according to findings from the Aspen Institute. If income-insecure women face losing their homes - and access to a stable address to receive voting registration, ballots, applications, and critical change-of-address forms - this could impact how many of them vote in the upcoming presidential election, experts say, adding this could also have a significant impact on the outcome of the November election.

> These aren't issues that people look at together, but they should be looking at together," says Shailly Gupta Barnes, policy director for the Poor People's Campaign and the Kairos Center.

Arecent NPR analysis found neighborhoods with higher evictions had lower voter turnout than the rest of the city, including other low-income neighborhoods.

Shenett, as chair of council's Community Life and Education Committee, reported that the committee will be convening in the near future to discuss and create an initiative regarding community and race relations. "We will meet and work with the city council subcommittees, starting with the Housing and Safety Committees, to come up with a more comprehensive plan to address the issues and challenges around racism," he said.

Shenett added, "We will ultimately present our plan to the mayor and request that it is added as an attachment to a comprehensive resolution joining the national movement declaring racism as a public health crisis.

Other legislation on agenda

As GOJO Industries prepares to open at 5700 Lee R. South, providing potentially hundreds of jobs and needed income tax revenue in the city, council moved forward with plans to facilitate access to the 325,000-square foot plant, by approving a resolution authorizing Blackwell to enter into a contract with Ronyak Paving for the Lee Road South Repair project, at a cost of \$148,900.

Council had passed a resolution at its August meeting authorizing Hren to begin plans and to advertise for bids for the project, and Ronyak submitted the lowest and best bid, last week's legislation stated. Earliest start date for the project given by Ronyak is Monday, Sept. 21, with completion expected in 45 days, Hren stated.

Also passed was legislation authorizing Blackwell to enter into a contract with Terrace Construction Company, Inc., for the Mapleboro Avenue Watermain Replacement Project, at a cost not to exceed \$253,135.90.

The city has been awarded \$365,061 from the Cleveland Division of Water, through the Suburban Water Main Renewal Program, and the project will be funded in part through that grant, Hren stated. The earliest start date given was Monday, Sept. 28, with completion expected in 45 days.

brought by the city in U.S. District Court against Netflix and Hulu on the grounds they have not been paying

to execute an agreement with the Northeast Ohio Regional Sewer District (NEORSD) for Community Cost Share Program Funds to obtain leaf collection equipment and rehabilitation of composting facilities at the city-owned property at 14580 Schreiber Rd., at a cost of \$87.500

Service Director Tony Ciresi has informed Blackwell and Hren that municipal leaf collection and composting can be provided most cost effectively by utilizing Service Department personnel.

The legislation also directs Ciresi to seek proposals for the leaf collection equipment and authorizes Hren to prepare plans and seek proposals for the compost facility

Council also passed an ordinance to remove all references to a garage sale permit fee from the codified ordinances after it was found that legislation passed in 2016 failed to amend conflicting garage sale fee provisions, adopted by council in 1993.

Residents must still obtain a garage sale permit from the Building Department before holding garage sales, but all references to fees were deleted. However, the phrase "During any 12-month period, no property or premises in the city shall be used for more than three garage sales,' remains as before.

Announcements

Fire Chief Vito Kavaliunas announced that the Maple Heights Fire Department responded to a fire in the 17000 block of Maple Heights Blvd. on Monday, Aug. 10, resulting in the death of Larry Wilkerson, 62. City officials expressed their condolences.

Officials congratulated Lt. Donald Grossmyer on his retirement this month after more than 29 years with the Maple Heights Police Department.

Blackwell commented briefly on the ongoing lawsuit

Council also passed a resolution authorizing Blackwell Maple Heights a mandated video service provider fee, amounting to 5% of their respective gross revenues.

> "I think we are going to prevail, and as mayor I will take every opportunity on behalf of our residents to go after these fees."

> Blackwell stated that residents were applying for jobs at GOJO, a grand reopening of the Farmer Jones Market was planned and two new houses were being built on Jefferson Avenue. Jones also stated that Reddi's Pizzawas going to reopen soon under new ownership.

Tax levies on Nov. 3 ballot

With absentee ballots being mailed out and people starting to vote, these are the two issues in the Nov. 3 presidential election affecting readers in The Neighborhood News distribution area:

CLEVELAND MUNICIPAL SCHOOL DISTRICT Proposed Tax Levy (Renewal and Increase): Arenewal of 15 mills and an increase of 5 mills to constitute a tax for the benefit of the Cleveland Municipal School District for the purpose of current expenses of the school district and of partnering community schools at a rate not exceeding 20 mills for each one dollar of valuation (of which 1.5 mills is to be allocated to partnering community schools), which amounts to \$2.00 for each one hundred dollars of valuation, for ten years, commencing in 2020, first due in calendar year 2021.

CUYAHOGA COUNTY LIBRARY DISTRICT Proposed Tax Levy (Additional): An additional tax for the benefit of the Cuyahoga County Public Library at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to 10 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2020, first due in calendar year 2021.

In Slavic Village, the worry is that voter turnout, which hasn't rebounded from the last housing crisis more than a decade ago, could get worse. In 2016, only 38.5 percent of eligible voters cast ballots, the second-lowest among neighborhoods in the city.

Cleveland and Cuyahoga County have allotted \$18.1 million in federal CARES Act and Community Development Block Grant money to help renters. As she goes door-to-door, Rodemann and others spread the word about the rental assistance program, administered by CHN Housing Partners, a housing nonprofit, which can cover rent for up to three months.

Energizing people to vote in a community like Slavic Village could prove difficult. The same has been true for encouraging people to fill out the U.S. Census.

The neighborhood has followed the pattern of other industrial and urban communities: a booming population at the start of the century, then deindustrialization post World War II, urban flight, and declining populations, empty homes and increases in poverty and crime rates

By the Great Recession, the 5-square-mile neighborhood had more foreclosures in its 44105 zip code during the spring and summer of 2007 than any other zip code

in the United States. The housing market, then in crisis across the country, was devastated in Slavic Village. As it continues its climb to recovery, the community again staves off another wave of housing displacement wrought by COVID-19.

Now get-out-the-vote efforts are more difficult as coronavirus cases top 5 million in the U.S. and nearly 4,500 in Cleveland. That's why a vote-by-mail application is included in the same handout packet alongside rent payment assistance information that Rodemann hands out.

Organizers are also helping voters navigate Ohio's ballot request process through smaller hands-on events at places like Daisy's Ice Cream on Fleet Avenue, and Neighborhood Pets, a local pet food pantry and resource center.

Women have consistently outpaced men in voter turnout across racial groups and education levels since the 1980s. And because women, as a voting bloc, have historically leaned toward Democratic party candidates, evictions could mean a partisan impact. In 2016, then -Democratic candidate Hillary Clinton led among women voters by 13 percent compared to President Donald Trump.

That gap has widened in 2020, putting former Vice President Joe Biden ahead of President Trump by 25% among women voters, according to recent polling.




