## Halloween Happenings Bedford City Council passes more Tinkers **Creek Commerce Park redevelopment legislation**

Following several pieces of legislation passed over the last few months to adopt an Urban Redevelopment Plan for the Tinkers Creek Commerce Park area, Bedford Council passed an additional resolution at its meeting Monday night to further facilitate the economic development of almost 30 acres of property in the Egbert Road neighborhood of the city.

Council passed a resolution to amend a previous bill to include a small parcel of land adjoining the larger parcels of land already approved for redevelopment for economic Water, sewer rates set development purposes.

The redevelopment of the real property, located at 3 Hemisphere Way, has become an important part of the city's economic development plan," according to the

## Garfield Hts. Council sets rules for operation of food trucks in city

Garfield Heights Council met in regular session on Tuesday, Oct. 12, a day late because of the Columbus Day holiday the day before, and passed an emergency ordinance to regulate the operation of "mobile" food service operations within the city, which includes businesses such as mobile catering, food trucks and farmer's-type

Now required for these type of businesses to operate in Garfield Heights are a Mobile Food Service Operations Permit from the city and a vendor's license. Restrictions will be enforced regarding loudspeakers, flashing or blinking lights, animated displays or any prohibited signage used to attract attention to the mobile business. Also regulated will be the number of days staying in one location, number of hours operating per day and between the hours specified in the legislation.

Also passed were two other emergency ordinances regarding mobile food service operations, one amending the General Fee Schedule and the other amending the chapter on Canvassers, Solicitors and Peddlers, to include the newly created regulations.

Council also passed legislation to sell municipal property no longer needed by the city, mostly used police

A resolution was enthusiastically passed commemorating October as National Breast Cancer Awareness Month.

Mayor Matt Burke, in his report to council, noted that  $Over Drive, with its world head quarters on Granger\,Rd.\,in$ Garfield Heights, has acquired an additional company and will bring another 75 new employees to the city.

The next regular council meeting is scheduled for Monday, Oct. 25.

The additional parcel of land, a little less than an acre according to the Cuyahoga County Fiscal Officer's website, is presently owned by 200 Egbert Road, LLC. The Egbert Road address is also listed on the county website as owner of the other parcels mentioned in Monday night's legislation.

City Manager Mike Mallis explained that the city has been working to redevelop Tinkers Creek Commerce Park, which is roughly 29 acres, with outside businesses and local businesses wishing to expand and potentially relocate to Bedford.

Council passed three pieces of legislation at Monday night's meeting to set water and sewer rates for 2022, and also to provide for a discount for senior and disabled property owners.

Finance Director Frank Gambosi said that the water rates would not go up for next year. However, sewer rates will increase in 2022 by 4%, he said.

As for the discount in water and sewer rates that was passed by council, regarding minimum income requirements, Gambosi said, "We have raised the amount for the senior discount; \$34,694 is what the new amount is for household income."

#### Also on agenda


Council approved an ordinance providing for the issuance and sale of bonds in the maximum principal amount of \$3,355,000, for the purpose of paying the costs of refunding, at a lower interest cost, a number of the city's outstanding various purpose improvement and refunding bonds from the 2013 debt issue.

Also passed was a change order in the amount of \$15,000 for additional engineering fees to GPD Group for services associated with the repair and resurfacing of Union Street in the city.

Council also passed an ordinance for a contract with Comfort Systems USA, for emergency replacement of an expansion tank to the boiler system for the Municipal Complex, at a cost of \$12,000.

Legislation allowing city employee participants to make insurance plan premium contributions on a pretax basis for 2022 through Health Equity Wage Works was also okayed by council.

## **Cleveland Council okays TIF for** new construction of apartments project

Cleveland City Council held its regular weekly meeting Monday night and adopted legislation authorizing the director of Economic Development to enter into a Tax Increment Financing Agreement or TIF for 5506 Detroit, LLC, to fund eligible project costs or projected debt for the financing of the Waverly & Oak Apartments Project.

The TIF diverts the increase in future property taxes – based on improvements – for up to 30 years though it does not exempt the developer from payment in lieu of taxes to ensure CMSD receives what it would have otherwise received but for the TIF. The \$47 million project includes 126 market rate rental units built over street level commercial environment with approximately 17,300 square feet of retail space with below grade and surface parking. The project will be the first new construction, mixed-use development along Detroit Avenue in Gordon Square.

Also adopted was legislation authorizing the director of Public Works to enter into a license agreement with Case Western Reserve University to use and occupy city-owned

properties located within the Doan Brook watershed to be used as outdoor learning environments for students in its Environmental Heroes program and to conduct water quality sampling and field investigations, for an initial term of three years and automatically renewing year to year unless terminated by either party.

Council passed legislation authorizing Cleveland police to join a statewide task force that investigates human trafficking. The legislation enables the director of Public Safety to enter into a Memorandum of Understanding with the Ohio Organized Crime Investigations Commission to assist with investigating human trafficking activity in Cleveland. Human trafficking has been and continues to be a grave problem on a worldwide scale as well as locally throughout Ohio and in Cleveland, said officials.


Council authorized the city to enter into a \$1.3 million loan agreement with the nonprofit Fairfax Renaissance Development Corp. and its partner McCormack Baron to assist financially with the development of a residential building at Hudson Avenue and East 105th Street along the Opportunity Corridor.

The project will include approximately 80 apartments: 20 studios; 44 one-bedroom units; and 16 two-bedroom apartments. The project will include market rate and workforce housing. Along with neighboring development projects, this will be the first attempt to develop market-rate and workforce housing at scale outside of downtown, University Circle and the Near West side neighborhoods.

The additional financial help is needed because market rents are not expected to reach the levels that "hotter" markets of the city are commanding and as such will not be able to subsidize the lower "workforce" rents as well as the increase in construction costs because of the pandemic.

This first building is part of a larger, long-term plan Fairfax has to expand Innovation Square with more building and houses to make it a pedestrian-friendly urban residential community that is inclusive of all income levels and life stages and providing opportunities to attract new residents while retaining Fairfax's long-term and committed residents.


Council also authorized the commissioner of Purchases and Supplies to sell city-owned property no longer needed for public use located at 10700 Churchill Avenue to The NRP Group LLC for purposes of implementing the future Churchill Gateway project; and authorizing retaining an easement and entering into an easement agreement for the public purpose of vehicular and pedestrian access.

This is the step in the redevelopment of a long-idled, soon-to-be demolished school. The NRP Group is working on the first phase of a multiphase development known as Churchill Gateway, and will consist of a four-story 48-unit apartment building and four townhomes, for a total of 52 units. The one-, two-, and three-bedroom units will be affordable to residents at or below 60% of the area median income.

In addition to delivering much-needed affordable housing to the neighborhood, officials said, NRP is collaborating with the city of Cleveland, Čuyahoga Metropolitan Housing Authority, Cleveland Metropolitan School District, and University Hospitals to develop a 2,500-square-foot Community Outreach Center, which will focus on health education and workforce training.





#### Candidate Brancatelli: What is your personal and professional background? How does this qualify you to represent Ward 12?

Growing up in Slavic Village we always had growing diversity in our schools and our community; I experienced it firsthand as a lifelong resident. I lived through the advent of busing and saw/heard the detractors. Racial equity needs to continue to be addressed in education, employment, housing, etc. I am proud of my accomplishments while on City Council and while on various Boards and Commissions. I have supported legislation on fair housing, domestic registry, employment protections, housing non-discrimination and public accommodations. I  $continue\ to\ require\ MBE/FBE\ and\ living\ wage\ requirements\ on\ projects\ receiving\ City\ benefits.$ 

#### Candidate Brancatelli: What aspect of local government is most important to you?

Ward 12 has 5 distinct areas: Old Brooklyn, Tremont, Brooklyn Centre, Slavic Village and the Industrial Valley. Each area has neighborhoods with specific needs. The aspect that is most important to me is understanding the unique and common issues in each of the neighborhoods by working with residents and businesses and to resolve those concerns through good policy, legislation, and budgeting locally and also representing our neighborhoods outside of the city to raise resources and awareness. For example, I have testified in Congress to fight predatory lending and remove blighted housing conditions which helped raise millions in relief.

#### Candidate Brancatelli: What is your vision for economic development in Ward 12?

I'll continue to help retain businesses and recruit new businesses in Ward 12, working with our local CDCs and financial institutions to identify gap financing and resources needed to grow our economic base and stabilize small businesses.

My efforts were recently recognized when I received the International Economic Development Council Leadership Award for Public Service. This award recognizes an elected official who has served as a committed advocate for economic development for at least 10 years in the public sector and displayed dedication and commitment to their constituency as a leader and advocate for economic development.

#### Candidate Maurer: What is your personal and professional background? How does this qualify you to represent Ward 12?

I'm a lawyer with a track record of work from my block, to the ward, to City Hall. My website

## Candidate Maurer: Do you support the charter amendment on the November

We need to do a lot to improve public safety: investing in violence prevention, decreasing police I strongly oppose Issue 24. Positive changes have been made via the Consent Decree and the data response times, and rebuilding the broken trust between residents and the police. That's why I support Issue 24. Even if there may be portions we have to iterate on in the years ahead, it's a step in the right direction to add a civilian police review board.

> $Some\ people\ are\ opposing\ Issue\ 24\ because\ of\ the\ improvements\ made\ since\ the\ Consent\ Decree.$ That's actually a great reason to support Issue 24 because it will make permanent the improvements we've seen and makes sure we won't slide backwards when the Consent Decree ends

#### Candidate Maurer: How has the principal of racial equity informed your career?

We are one of the most segregated cities in America — and we are also one of the poorest. Segregation was planned and enforced through systems like the 1940s "redlining" maps. Today we still see inequalities like internet access along those same lines. Your zip code and your race determine so much of your life here in Cleveland. That's why much of my legal career has been driven by a pursuit of racial equity and I plan to bring those same skills with me to City Hall. In an area as diverse as Ward 12, our neighbors deserve nothing less.

### Candidate Maurer: What aspect of local government is most important to you?

I care about making sure Clevelanders are safe and have the bread-and-butter city services they deserve. I also care deeply about re-engaging Clevelanders with their local government and making them trust that their participation in Čity Council meetings and block clubs will improve their quality of life.

### Candidate Maurer: What is your vision for economic development in Ward 12?

Our economic development goals should be focused on creating more quality jobs for city residents, and safer and healthier neighborhoods. We have many tools at our disposal to propel that work, such as grants, loans, and tax breaks. But I believe Cleveland must be more strategic and focused when providing incentives. We need to focus on housing rehab, energy-efficient housing, transit, and public internet. These are investments that can lower household costs, employ current residents, and build a city of the future. Additionally, we must also build a local economy that is more resilient and less impacted by downturns in the national or global economy or pandemic conditions.



## **GHPD** offers Happy Halloween Hints

The city of Garfield Heights will celebrate Halloween on Sunday, Oct. 31, from 6 to 8 p.m. The following hints are provided by the Garfield Heights Police Department to assist in everyone's safety:

- 1. Young children should be accompanied by parents or other responsible adults on the "treating" visits.
- 2. Treating visits should be confined to your neighborhood.
- 3. Treating visits should be confined to the 6 to 8 p.m. timeframe.
- 4. Residents who wish to welcome treaters should turn on their front exterior light as a sign of their hospitality.
- 5. Children should call only at homes with their outside lights glowing.

- 6. Halloween costumes should be light in color, short enough to prevent tripping and non-flammable. Reflection tape, so they "glow" in the beam of a car's headlights, should be placed on clothing.
- 7. Follow the basic pedestrian rules:
- a. Cross only at corners, never between parked cars, and never diagonally across an intersection.
  - b. Look in all directions before crossing the street.
  - c. Watch for and obey all traffic lights and stop signs.
  - d. Walk, never run, across the street.
  - e. Use sidewalks, not the street, for walking.
  - f. Wait on the curb, not in the street, until the street is clear to cross.
- 8. Motorists should be alert and use extreme caution during the treating time.
- 9. Children should carry a flashlight in their bag for added visibility.
- $10.\,\mathrm{Bring}\,\mathrm{your}\,\mathrm{treats}\,\mathrm{home}\,\mathrm{so}\,\mathrm{parents}\,\mathrm{can}\,\mathrm{see}\,\mathrm{them},$  and don't eat treats that are not wrapped.

The Cuyahoga County Board of Elections is advising voters to be mindful of completing all the yellow highlighted sections on the Vote-by-Mail ballot application. The most common error found on an application has been a date of birth missing, or an alternate date, such as the current date, being written in.

Voters whose Vote-by-Mail ballot applications have been rejected are sent a letter detailing the reason(s) their application has been rejected, a new Vote-by-Mail ballot application, and information on how to contact the Ballot Department.

It urges all voters to take a second look at their Vote-by-Mail application to ensure all the sections are complete and correct before sending it in to the Cuyahoga County Board of Elections.
