Garfield Hts. Council considers upping its salary to \$18,000 a year; first raise in 15 years

Garfield Heights Council, at its regular Monday night meeting, passed to a second reading an ordinance to raise the salary of council members to \$18,000 per year, effective Nov. 13, 2023, the first day of the next council term.

Council members currently receive \$15,125 per annum. The legislation will again be considered at the next regular meeting of council.

Passed at the meeting were the following ordinances and resolutions:

•To renew an agreement on behalf of the city with the Cuyahoga Soil and Water Conservation District to participate in the Storm Water Pollution Prevention Program.

•To advertise for proposals for various materials, services and supplies for the year ending Dec. 31, 2023.

•To submit a payment of \$6,000 to the Cuyahoga Soil and Water Conservation District and Northeast Ohio Regional Sewer District for public involvement and public education regarding soil and water conservation for 2023.

•To ratify the appointment by the mayor of Ike Dawson, Sr. to the Neighborhood Advisory Committee Land Reutilization Program of the city for the term effective immediately and ending Dec. 31, 2026.

•To apply for the Cuyahoga County Solid Waste District's the 2023 Community Recycling Awareness Grant of up to the \$6,000. o

•To honor and congratulate Fr. Thomas Haren on his retirement. He has been pastor of St. Monica's Catholic Church in Garfield Heights for over 17 years. Among his other pastoral assignments was at Holy Name Church, where the parish hall was named after him. He will live in residence at the St. Michael Church rectory in Independence, according to City Council President Tom Vaughn.

Rapist sentenced for attack in Slavic Village

Tyrese Acoff, 29, who pleaded guilty last month to rape, kidnapping and gross sexual imposition in a home in Slavic Village last August, was sentenced to 35 to 40 years in prison yesterday in the courtroom of Cuyahoga County Common Pleas Judge Deena Calabrese.

On Aug. 10, 2022, Acoff attacked a 12-year-old girl inside a home near Marble and Broadway aves., Cleveland, and sexually assaulted her. He then forcibly carried her into another room, sexually assaulted her again, and then fled the scene. On Aug. 13, Acoff was arrested, according to information provided by the Cuyahoga County Prosecutor's Office.

Car flips but only minor injuries reported during Valley View police pursuit

Valley View police officers tried to pull a Chevy Equinox over last Friday for expired plates at Bank St. and Canal Rd., and a pursuit ensued when the car took off, said Valley View Police Detective Joe Ferrando.

As the car traveled down E. 71 St. in Cuyahoga Heights at reckless and excessive speeds, CHPD set up stop sticks in the road near Grant Ave., the detective said. When the speeding car hit the sticks it punctured the tires, and as the car continued to ride on the rims and shredding tires, the driver lost control and went off an embankment and onto a parking lot near Grant and E. 71 St., flipping over.

The three people inside were able to get out of the car and flee on foot, but officers from Valley View, Newburgh Heights and Cuyahoga Heights were able to catch them within minutes.

Two of the three people inside the car were taken to MetroHealth Medical Center with minor injuries and released from the hospital later that day, Detective Ferrando said.

He said two guns were found inside the car, and two of the individuals inside were wanted on warrants and taken into custody by Newburgh Heights police.

Shooting, suicide on Gertrude Ave. in S.V.

A felonious assault shooting and suicide took place last Saturday night in the 6400 block of Gertrude Ave., in Slavic Village.

Cleveland police said a 21-year-old female was shot in the neck and chin, and a 25-year-old male died of a selfinflicted gunshot wound to the head. He was pronounced dead on scene by medics at 10:15 p.m. Saturday. A dog was also shot.

According to preliminary reports from the Cleveland Police Department, the male shot his girlfriend and her dog, then shot himself. This investigation is ongoing.

SVD awarded grant from Ohio State Bar Association

The Ohio State Bar Association has donated \$644,685 to Ohio nonprofit organizations in its latest grant cycle, including \$50,000 awarded to Slavic Village Development, at Broadway and E. 55 St., Cleveland.

Slavic Village Development is using the grant funds for an Eviction Prevention Pilot Project, which seeks to reverse the high rate of eviction in the Slavic Village community through tenant rights education and proactive legal services.

Over the past few years, SVD has noticed an alarming rise in out of town rental companies buying up local property and raising rents beyond what most neighborhood tenants can afford, said Zachariah Germaniuk, director of Neighborhood Stabilization at SVD. These rental increases have been arbitrary and not based on any improvement of property conditions, property tax increases, and far outpace the normal rate of inflation, he said.

This is especially harmful to many elderly tenants and families with children who are not in a position to move and often have strict budgets, Germaniuk said. To help stabilize its aging renter-neighbors, at the end of 2022, SVD established the Eviction Prevention Pilot Program with the \$50,000 grant from the Ohio State Bar Association.

The program seeks to achieve two primary goals: 1) empowering tenants with information and support necessary to hold absentee landlords accountable for substandard property conditions; 2) placing qualifying tenants on a path towards better housing, including possible homeownership through one of its housing rehab programs - Neighbors Invest in Broadway or Slavic Village Rediscovered.

Maple Heights Council passed a resolution to observe the birthday of Dr. Martin Luther King, Jr. and honor his life at its first meeting of 2023 on Wednesday, Jan. 4.

The late civil rights pioneer, who was born Jan. 15, 1929, is honored every year with a federal holiday on the third Monday of January, which this year is Monday, Jan. 16. The resolution, which was the sole piece of legislation on last week's agenda, was passed unanimously.

Dr. King "changed our nation forever through his leadership, service and clarity of vision," states the legislation. "He devoted his life to strengthening the content of the American character, and called on our nation to live up to its founding principles of life, liberty and the pursuit of happiness for all its citizens... through his determination, spirit and resolve, Dr. King helped lift available from the city.

souls and lead one of the greatest movements for equality and freedom in history." All citizens are encouraged to honor Dr. King, "not only upon the occasion of his birthday but throughout the whole year, by living out his teachings as we continue to work for the day when the dignity and humanity of every person is respected."

It's time to start getting your affairs in order for the new year and The Legal Aid Society of Cleveland can help!

Legal Aid has been offering free civil legal services to those with low incomes (up to 200% federal poverty guideline) since 1905 – the fifth oldest legal aid organization in the United States. Legal Aid not only serves residents in Cuyahoga but also in Ashtabula, Geauga, Lake, and Lorain counties.

Call Legal Aid if you need help with:

•Housing: foreclosure, eviction, landlord/tenant issues, utilities, public housing

• Work: unemployment compensation, IRS tax issues, sealing criminal records, securing a valid ID or professional license

• Money: loans (school, payday, auto, debt), public benefits (food stamps, energy assistance, cash assistance, supplemental security income), bankruptcy

• Family: domestic violence, divorce, custody, immigration, education, estate planning

•Health: medical bill collection, access to medical records, Medicare and Medicaid, marketplace tax credits and penalties

Legal Aid provides assistance with civil legal issues but cannot assist with applications for benefits or criminal cases.

Legal Aid attorneys provide one-on-one consultation at Brief Advice Clinics and represent clients at court and administrative hearings. Attorneys also go into the community to educate residents regarding their rights and the services that are available to prospective clients.

Legal Aid helps clients like Deja (not her real name). Deja made her rental payments on time each month – until the pandemic hit. She had to change jobs and lost a significant amount of income as she struggled to find childcare for her daughter, who was no longer going to school in-person.

She fell behind in her rent and soon received an eviction notice. She also owed increasing late fees which were snowballing at \$25 per day.

Once connected with Legal Aid, an attorney helped Deja apply for rent assistance through CHN Housing Partners, and her application was approved. Deja's attorney was then able to negotiate with her landlord to accept that money as back pay plus three months of future rent payments.

Bedford Councilman Smith sworn in after election to unexpired Ward 4 council seat

Bedford Mayor Stan Koci swore in Frank Smith to the remainder of an unexpired term as the city's Ward 4 Council representative, at council's 2023 organizational meeting on Tuesday, Jan. 3.

Smith was appointed in May of last year to fill the vacancy left in the Ward 4 seat after longtime Councilwoman Paula Mizsak died in February.

According to the city charter, following his appointment in May, Smith was required to run in the November 8, 2022 General Election to fill out the remainder of Mizsak's unexpired four-year term, which ends December 31, 2023.

Smith ran unopposed in the November election, receiving a total of 376 votes, and can run for a new four-year term in the November 2023 election.


